

OFFICIAL OBEDIENCE ENTRY FORM

INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

If the class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.

- A dog must be entered in the name of the person who actually owned it at the time entries for the event. The dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

- Dogs listed in the AKC Canine PartnersSM Program may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name appears above. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of the event in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry or the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and entered in any event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to the event employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, handling or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for the event and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to the dog or to the dog's property. I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties because of bodily injuries, including death at any time resulting therefrom, sustained by any person or thing (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in the event. I (we) agree that the determination of whether the injury is serious shall be made by the event veterinarian and I (we) agree that ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO MY (OUR) PARTICIPATION IN THE EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING ORGANIZATION (OTHERWISE STATED IN THIS PREMIUM LIST) AND MYSELF (OURSSELVES) OR AS TO THE INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, THE ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES SHALL BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS AND GUIDELINES.
